- 22 February, a.m.: "The special order for this hour being **House Bill No. 5**, To prevent mob violence, was taken up.—Pending consideration, Mr. Hanna moved to adjourn until 2 o'clock p.m.—Mr. Harris moved to adjourn until 10 o'clock to-morrow morning, out of respect to the memory of George Washington, which was lost.—The question recurring upon the motion to adjourn until 2 o'clock p.m., was agreed to."
- 22 February, p.m.: "The unfinished business being consideration of **House Bill No. 5**, To prevent mob violence, was taken up.—The question being upon the adoption of the substitute offered by the Judiciary Committee.—Mr. Hurt moved the previous question upon the passage of the substitute, which was sustained, pending which Mr. Whitthorne moved to lay the bill and the substitute upon the table.—The ayes and noes were called, and the motion prevailed by the following vote: Ayes 41, Noes 36. [*Names are listed.*]—The regular order was resumed."
- 22 February: "**Mr. McElwee, House Resolution No. 146**, Tendering the use of the hall, etc.—Lies over."

- 24 February: "House Bill No. 6, To amend Article 4, Chapter 4, of the Code, Sections 3285 and 3288.—The substitute offered by the committee was adopted, and the bill as amended passed the third reading by the following vote: Ayes 73, Noes 0."
- 28 February: "By **Mr. McElwee, House Bill No. 780**, To repeal the charter of the Holly Springs, Brownsville & Ohio Railroad Company.—Passed first reading."
- 1 March: "House Bill No. 780 . . . Passed second reading, and referred to Committee on Railroads."
- 2 March: "House Joint Resolution No. 83, Relative to the reception of cadets of the University of Tennessee.—Passed over informally."
- 11 March: "By unanimous consent, **House Bill No. 780**, To repeal charter of Holly Springs, Brownsville & Dyer County Railroad Company, was taken up.— **Mr. McElwee** moved to strike out all after the enacting clause and substitute Senate Bill No. 348, on same subject.—Agreed to.—And the bill, as amended, passed third reading without call of the roll.—A motion to reconsider was laid on the table."
- 14 March: "House Joint Resolution No. 83, Relative to reception of colored cadets in the University of Tennessee.—Mr. McElwee moved to amend by striking out Central Tennessee College and Roger Williams University.—Which was agreed to, and the resolution, as amended, was adopted."
- 28 March: "The following message was received from the Senate: MR. SPEAKER—By direction of the Senate, I transmit Senate Bill No. 494, In reference to Cincinnati, Chicago & Charleston Railroad Company, passed by the Senate; also House Joint Resolution No. 83, and House Bills Nos. 377, 575, 881, 451, and 875, and House Joint Resolution No. 176, signed by the Speaker of the Senate.
